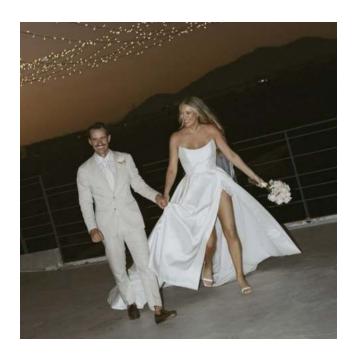
TEAM NEWS

MARKET COMMENTARY

The much-anticipated rate cut finally occurred in the 3rd quarter, providing relief with a larger-than-expected 0.5% reduction. This sparked optimism and broad gains across major asset classes. Unlike recent quarters where the "Magnificent 7" tech giants led the S&P 500, "the other 493" stocks drove the index higher this time. The other equity classes also outperformed the S&P 500 overall.

The larger rate cut could be attributed to a weakening labor market, often a precursor to a recession. Despite the Fed's commitment, a faltering labor market is tough to stabilize. Historically, rate cuts preceded the onset of recessions, suggesting caution is still warranted. As mentioned in the last quarterly commentary, the Fed still faces a delicate balance: act too slowly and risk recession, act too quickly and risk persistent inflation.

With an upcoming election adding to market uncertainty, expect increased volatility. As a reminder, we should base decisions on financial goals and plans, not emotions. Regardless of election outcomes, history consistently shows the market tends to rise over the long term no matter who's in office or what interest rates are currently at.
